book adopts a novel analytical approach to understanding how Russia's stalled democratisation is related to the incomplete liberalisation of the economy. Based on extensive original comparative study of Russia's regions, the book explores the precise channels of interaction that create the mutuality of property rights, entrepreneurship, rule of law, norms of citizenship and liberal democracy. It demonstrates that the extent of democratisation varies across regions, and that this variation is connected to the extent of liberalisation of the economy. Michael Ledeen is a senior associate of the Center for Strategic and International Studies at Georgetown University, and formerly taught history at Washington University. He was the founding editor of *The Washington Quarterly*, and is the author of, among other works, *Grave New World; The First Duce: D'Annunzio at Fiume*; and editor of *U.S. Defense and Foreign Policy*.

Palmiro Togliatti Aldo Agosti 2008-07-30 Palmiro Togliatti could not have become leader of the Italian Communist Party at a more difficult time in the Party's history.
